*** Cancellation Announcement ***

Due to the massive, widespread wildfires that have devastated San Diego County since Sunday (and continue to burn in the Northeast and Southeast parts of the county) we have decided the best and most prudent course of action is to cancel the 14th Annual Sempra Energy San Diego Triathlon Challenge and the Frog's Fitness Tour de Cove scheduled for Sunday, Oct. 28, 2007 at La Jolla Cove.

The safety, well-being, and enjoyment of all our event participants were the major factors in our decision-making process. At this point, we do not know what the air quality will be like on Sunday. We are also cognizant of the great losses suffered by many of our friends and neighbors across the county. We believe that after four days of severe disruptions that affected more than 500,000 San Diego County residents, and with an uncertain air quality forecast for Sunday, it is best not to proceed with the event at this time.

CAF thanks all our sponsors, friends and volunteers who have worked so hard to make this year's San Diego Triathlon Challenge and Tour de Cove a success. Like you, we are very disappointed that the event will not go forward this weekend. However, we truly believe this is the right course of action. Thank you for your continued support of physically challenged athletes.

Featuring...Tim and Joyce Bunch

This newlywed couple actually started out life in the same place...they were both born in San Diego at Balboa Hospital. Other than the five years Tim lived in North Miami Beach, Florida, and Joyce's short time as a young child in Anniston, Alabama, they have spent most of their lives in San Diego.

Tim, an architect with his own small firm, specializes in commercial and industrial projects and handicap accessibility studies. Joyce worked in retail, manufactured electronic Medical Research equipment for Hospitals and Universities worldwide and recently is a retired Deputy Sheriff, due to a back injury. 



Marilyn and I had 2 couples come to our front door searching for shelter from the FIRESTORM.

One couple from Ramona -- Bob spends most of his life in a wheelchair. MS crippled him about 20 years ago. His wife Jan is a RED HAT woman with the same group Marilyn joined up with. Bob and Jan have been our friends for about 30 years. At one time they rode across the United States on bicycles. Then MS came along and changed their lives. They brought with them there full grown dog and also a cat. They have two of their full grown children who work for the San Diego Fire Department.

The other couple lives in Julian. They also have been friends of our probably for about 30 years. They lived in the Country Estates for several years. They sold that home the day before the Cedar Fire was started. In the process of moving they had purchased a piece of land on Pine Hills Drive in Julian. They had a trailer moved onto the property to live in where their new home was to be built. They have a son who lives in Poway; he's a school teacher at Poway High, and they were staying with his son for a couple days before moving up to Julian. Can you guess? The Cedar Fire burned up into Julian and destroyed the trailer and most all the trees on their new property. After several months their new home was completed and they moved in. It is a wonderful home and now most the growth is filling in again.

Now they are back to Julian after staying with us for awhile. There's is a threat that this new home may be run over by this current fire. They didn't / don't have electricity! They were told to be ready to evacuate last Monday. They packed and came to our home here in Poway for shelter. They brought with them 3 large dogs. The dogs are very well trained. It seems odd but they were told to be ready to evacuate by two men from the COAST GUARD. NO ELECTRICITY, no TV, no communications. San Diego County was in the starting stages of a massive fire, and they weren't aware of it. NO - they don't do text messaging!

So we had a senior citizens gathering here at our home for a few days. Truthfully it was a lot of fun for all of us - other than the worry about the movement of the firestorm.

If it weren't for the fear of attorneys, someone would probably get airborne and seed these clouds to get some rain down on the ground here in San Diego County.


